Under sub-section (3) of section 14 of the Andhra Pradesh Town Planning Act, 1920 (Act 7 of 1920) as amended by Act No.24 of 1981 the Government hereby sanction the General Town Planning Scheme of the Bobbili Municipality, Vizianagaram District as approved by the Municipal Council in their Resolution No. 37/2003, dated 30.7.2003 subject to the condition that the Zoning Regulations, Floor Area Ratio and Building Requirements shall be as per G.O.Ms.No.422, MA., dated.31.07.1998.

2. The Municipal Commissioner, Bobbili Municipality, Vizianagaram District is requested to ensure that a copy of the scheme is kept open for inspection by the public at the Municipal Office and also at the Offices of the Panchayats affected by this Scheme during the office hours for a period of six months from the date of publication of the Notification in the Andhra Pradesh Gazette.
3. The Director of Town and Country Planning, Hyderabad, is requested to communicate a copy of the Master Plan covering the areas of vicinity of Gram Panchayats of Bobbili Municipality to administer the Town Planning Scheme within their area.
4. The appended notification will be published in the Andhra Pradesh Gazette along with the Zoning Regulations.
5. The Commissioner of Printing, Hyderabad is requested to furnish 1000 copies of the Notification to the Director of Town and Country Planning, Hyderabad.
