ORDER:

Orders were issued to waive the interest on arrears of property tax and interest in the Municipalities and Municipal Corporations upto 30.09.2005 vide the reference 1st read above subject to the condition that the tax payer pays the total arrears and current year property tax in one lump sum or in installments on or before 30.09.2005.

2. During the conference of Municipal Chairpersons and Mayors on 25th November, 2005 at Marri Chenna Reddy Human Resources Development Institute, Hyderabad, they have represented to extend the waiving of interest on arrears of property tax and interest up to 31st March, 2006.

3. Government after careful examination, in exercise of the powers conferred under Section 387-A of the A.P. Municipalities Act, 1965 and under Section 679-E of Hyderabad Municipal Corporation Act, 1955 have decided to further extend the time limit up to 31-03-2006 to waive the interest on arrears of property tax in Municipalities and Municipal Corporations in the State subject to the condition that the tax payer pays the total arrears and current year property tax in one lump sum or installments on or before 31-03-2006 and that this benefit will not be extended any further.

4. All the Municipal Commissioners of Municipalities / Corporations in the State shall follow the above orders scrupulously.
