ORDER:

In the G.O. first read above orders have been issued for the constitution of Municipal level / District level / State level co-ordination committees to take up monitoring of the implementation of the various activities under INDIRAMMA Programme.

In the G.O. second read above, orders have been issued for identification of Wards and other preparatory works in the Municipal Corporations and Municipalities for implementation of Phase-II of the INDIRAMMA programme for 2007-08.

The Commissioner and Director of Municipal Administration in the letter third read above has requested the Government to constitute **Implementation-cum-Monitoring Committees** in Urban Local Bodies as there are no such Committees in the Urban Local Bodies.

Government after careful consideration, hereby order for constitution of the Ward level / Division level **Implementation-cum-Monitoring Committees** in **Urban Local Bodies** as detailed below:

Wherever Councillors / Corporators are not there, the Commissioner will suggest the name of one person as Chairman from among the members of the Committee, to the District In-charge Minister through the Collector.

The names of the members of the group will be submitted by the Secretary in consultation with the Chairman to the concerned Commissioner and the Commissioner will submit the consolidated list to the District Collector. The District Collector will take the approval of the In-charge Minister and constitute the Implementation-cum-Monitoring Committee at the Ward / Division level.

The Implementation-cum-Monitoring Committee will discharge the following functions:

1. To take up awareness campaigns regarding the programme on the continuous basis.
2. To monitor the implementation of the various activities sanctioned under the programme.
3. To ensure that only eligible persons get the benefit under the programme.
4. To report to the Commissioner concerned about eligible beneficiaries, if any left out and the ineligible beneficiaries if any sanctioned any benefit under the programme.
5. The Commissioner will consolidate the list of eligible beneficiaries and submit it to the District Collector, who will place it before District In-charge Minister for final approval.

All the District Collectors and the Municipal Commissioners are requested to organize necessary orientation programme to the members of these committees at Urban Local Body level by utilizing the services of trained District Resource Persons.

All the District Collectors and the Municipal Commissioners are requested to take necessary steps to constitute these committees by 15th March, 2007.
