ORDER:

In the reference first read above the Chairman, Panineeya Sanskrit College Trust has informed that it is a charitable trust situated at Dilshuknagar, Hyderabad and engaged in the service of the Society since 34 years in the field of education. . He has stated that they are expanding the activities of the Trust by constructing five buildings consisting of 2,01,200/ sft , (building 1, with 7,000 sft; building 2, with 10,000 sft; building 3 ,with 79,000 sft; building 4 with 5,000 sft; and building 5 with 100,200sft) . He requested that all the charges for the proposed construction of the buildings be exempted in lieu of the costly land to an extent of 11/2 acres given to GHMC free of cost for road widening.

2. The Commissioner and Special Officer, Greater Hyderabad Municipal Corporation, in the reference third read above has informed that five buildings with a total built up area of 2,01,200 sft are proposed for construction by the Panineeya Sanskrit College Trust at Vivekananda Nagar, Dilshuknagar, Hyderabad and the trust has requested for exemption of building permission charges in lieu of the land given free of cost for road widening. The Commissioner and Special Officer, Greater Hyderabad Municipal Corporation, has stated that the building permit charges for the five buildings would be approximately Rs.30.00 lakhs.

3. The Government after careful consideration of the matter hereby exempt the building permit fees etc., to an approximate extent of Rs.30.00 lakhs (Rupees thirty lakhs only) for the proposed construction of five buildings with a built up area of 2,01,200 sft., by the Panineeya Sanskrit College Trust at Vivekanandanagar, Dilshuknagar, L.B. Nagar, Hyderabad in lieu of the 1.5 acres of valuable land surrendered to Greater Hyderabad Municipal Corporation free of cost for road widening.

4. The Commissioner and Special Officer, Greater Hyderabad Municipal Corporation, Hyderabad is requested to take necessary further action accordingly.
