ORDER:

In the reference first read above, the Chairman and the Managing Director of the Dr. Ranga Reddy Lions Eye Hospital has represented that Dr. Ranga Reddy Eye Hospital is a charitable and non profit organization and the Government has allotted three acres of land for construction of World class eye Hospital, and requested to waive the Betterment charges Development charges, layout charges and charges payable to Greater Hyderabad Municipal Corporation of Hyderabad, for construction of the hospital building at Upperpally village, Rajendranagar Mandal, Ranga Reddy District. In the reference second read above, the Vice Chairman, Hyderabad Urban Development Authority, has informed that the building plans submitted are in order and as per G.O. Ms. No. 86 M.A&U.D. Dept Dated : 03-03-2006, and as per the plans the applicant has to pay Development charges of Rs.17,07,467.00/=and proportionate layout charges of Rs.15,61,104.00/= to Hyderabad Urban Development Authority and the GHMC charges would come to Rs.Rs.7,26,000/=.

2. In the circumstances read above, the Government after careful consideration of the matter hereby exempt Dr. P. Ranga Reddy Lions Eye Hospital in Sy.No.36 (P) of Upperpally village, Rajendranagar Mandal Ranga Reddy District, for their proposed building from payment of fifty percent (50%) of the development charges, layout charges and betterment charges payable to Hyderabad Urban Development Authority and the Greater Hyderabad Municipal Corporation, Hyderabad.

3. The Vice Chairman, Hyderabad Urban Development Authority and the Commissioner and Special Officer, Greater Hyderabad Municipal Corporation, are requested to take necessary further action accordingly.
