# 1. BACKGROUND & OBJECTIVES OF EOI

The Andhra Pradesh Backward Classes Co-operative Finance Corporation (APBCCFC) is engaged in implementing welfare programmes and development schemes to empower the backward classes in the state by improving their productivity and help create additional income for them. As part of this endeavour, the Government of Andhra Pradesh has decided to re-launch the ADARANA Scheme, a flagship scheme for the backward classes. The scheme aims to provide modernized tools to artisans belonging to backward classes and thus contribute to increased income levels. The total budget allocated under the ADARANA scheme is Rs. 750 Cr. Details of ADARANA scheme have been issued through G.O.Ms. 1 Backward Classes Welfare Department dated 10/03/2018. The GO is enclosed at Annexure I of this document.

The VC & MD, APBCCFC had selected the suppliers to supply tools under Adarana scheme through a Rate contract process earlier. There are about 200 tools pertaining to various occupations shortlisted under Adarana scheme. This EOI is issued for empaneling or shortlisting interested firms / institutes / universities as TPIAs for performing the inspection, quality check and ascertaining the standards of the tools which would be supplied to the identified storage points across the state. (175 Assembly constitutions in Andhra Pradesh). The detailed scope of work, modalities of the assignment will be shared with the participants of the EOI.
